

Location Map






Public Consultation Submission Summary



- The emerging preferred route for the corridors was put on public consultation in January 2019.
- A total of 10 submissions were received and logged for the Clondalkin to Drimnagh CBC (8) scheme.
- A total of 76 submissions were received and logged for the Greenhills CBC (9) scheme. These included submissions with multiple signatures
- Notes from 39 engagement meetings with property owners, were also logged.







The design of junctions are evolving to take into account the high volume of HGV's and providing more segregation to cyclists at junctions



























